

## Specialist Music Teacher - Manor Field Primary School - June 2019

You will be responsible to the Headteacher to promote and support the progress of all children to achieve the highest possible standards in music. This role is to cover the teachers' PPA as well as lead on music at Manor Field.

### Main purpose of the role:

- Provide a high quality music education so that pupils develop a love of music and develop their talent as musicians
- Create music based opportunities and events both in school and the wider community
- Co-ordinate extra-curricular music activities

#### General:

- Support the vision, ethos and policies of the school
- Make a significant contribution to the aims, objectives and implementation of the school improvement plan
- Ensure high standards of professional conduct
- Lead choirs across the school and co-ordinate performances throughout the year
- Lead recorder and band after school clubs
- Co-ordinate school based music concerts throughout the year
- Provide music support for school productions
- Lead school music assemblies

### **Teaching and Development:**

- Teach music as set out in the National Curriculum to all year groups including: understanding and using musical language; learning about a variety of styles, genres and composers; learn to improvise and compose on a variety of instruments
- Lead on curriculum design for music, monitor and evaluate aspects of teaching, learning and assessment for music
- Lead by example as a music teacher, modelling exemplary classroom practice
- Participate in continued professional development opportunities

### **Communication:**

- Update the Senior Leadership Team on the effectiveness of music provision for pupils
- Liaise and collaborate with teachers and other professionals in relation to music
- Develop and maintain effective relationships with the wider school community

### **Additional Duties:**

- Promoting and safeguarding the welfare of all pupils
- Ensuring a high standard of care for pupils is consistently maintained
- Carrying out any other duties to ensure the smooth running of the school which might reasonably be requested by the Headteacher

The range of duties listed above extend the role of a music teacher, but do not replace such other duties that may be required, as laid down by the School Teachers' Pay and Conditions Acts. All teachers will work within the framework of such legislation, as well as within LA and school policies and guidelines on curriculum and organisation. Specific variations will be made by negotiation with the Headteacher and Governing Body.
